With regard to your request, please be advised that a search has been conducted in the Executive Office for OCDETF and 97 records, totaling 121 pages, have been located that may be responsive to your request. While carefully processing these documents, OCDETF has determined that 25 of the 97 records, totaling 38 pages, are unsuitable for release and are being withheld in full pursuant to Exemption 5 of the FOIA, 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.

Additionally, this Office has determined that 72 of the 97 records, totaling 83 pages, are appropriate for release with excisions made on behalf of the Executive Office for OCDETF pursuant to Exemption 5 of the FOIA, 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.
