I am writing in response to your letter, dated November 12, 2007. In that letter, you asked the Office of Special Counsel (OSC) to provide you with certain records or information from OSC files. We appreciate your patience during the delay in responding to your request.

After reviewing your request, and pertinent information about the records or information that you asked for, under the Freedom of Information Act (FOIA)¹, my response is shown in the enclosure with this letter. The enclosure lists possible responses applicable to requests for information, including FOIA exemptions that may be relied on to withhold agency records. An "X" appears in brackets beside any exemption(s) or other response(s) applicable to your request.

Please note that the enclosed lists of FOIA requests and appeals (encompassing Fiscal Years 2004-2008) constitute our FOIA "logs" in the sense that they are readily produced by OSC's electronic case tracking system. Given that these reports provide a minimal array of data points, OSC will produce, at your request, a customized report which includes information regarding the nature of each request and OSC's FOIA decision in each instance for a fee of \$342.50.

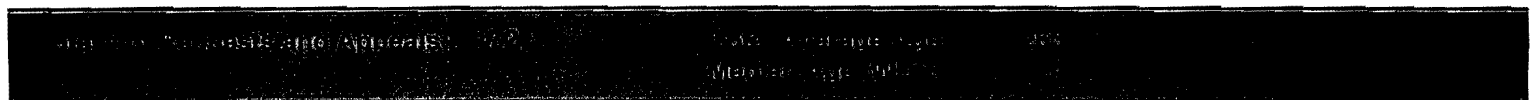

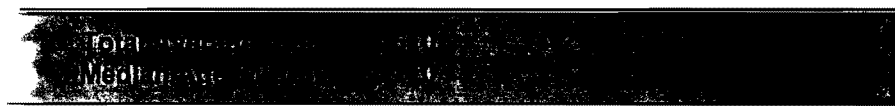
