This letter is the final response to the above-referenced requests for information you sent to the Council on Environmental Quality (CEQ) under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. You requested the following:

A copy of the FOIA Case Log for the Council on Environmental Quality for each of the calendar years 2010 through 2020.

Although you requested records for each calendar year, a strict search of calendar year logs would have resulted in no responsive records, as our annual FOIA records are arranged by fiscal years. In the interest of transparency, we are voluntarily providing you with records similar to what you have requested. CEQ's fiscal year FOIA logs for this date range are enclosed and has been posted on our website here: <https://www.whitehouse.gov/ceq/foia/> We did not find records matching your description for fiscal years 2010-2012.

This release constitutes a release in full. No exemptions were applied. Release of this information does not foreclose CEQ from alter claiming an exemption or privilege with regard to any similar documents in response to a subsequent FOIA request.
