The Washington Metropolitan Area Transit Authority (WMATA) now provides the final response to your remanded March 17, 2022, Public Access to Records Policy (PARP) request for "a copy of the listing or listings of Investigation Reports produced by the WMATA Office Of Inspector General." You further specified that the timeframe for your request is "2010 to the present [1]"

Your request for records was processed pursuant to WMATA's Public Access to Records Policy (PARP) and Privacy Policy.[2]

Previous Decision, Appeal, and Remand

On May 13, 2023, WMATA issued its final decision informing you that "[a]fter a search reasonably calculated to locate all records, WMATA found no records responsive to your request for '…a list of Investigation Reports produced by the WMATA Office Of Inspector General.' "On Monday, May 16, 2024, you appealed WMATA's decision. On May 24, 2023, the Appeal Panel issued its decision regarding your appeal and noted that in "the interest of increasing transparency and because compiling this list would require minimal effort," your request was remanded for further processing.

Decision

Please find attached the following record responsive to your request (5 pages total):

OIG Reports of Investigation January 2010 - March 2022.

Pursuant to PARP Exemption 6.1.6 (personal privacy) and Exemption 6.1.7 (c) (privacy law enforcement records), we redacted personal information where we have determined that the individual's privacy interest outweighs any public interest in disclosure.
