This letter responds to your Freedom of Information Act/Privacy Act (FOIA/PA) appeal dated January 29, 2020, and the Department of Justice, Office of Information Policy appeal remand letter dated May 15, 2024, received by the Drug Enforcement Administration (DEA), FOIA/PA Unit, seeking access to information regarding the above subject.

Responsive records identified during the processing of your request will be released to you. The portions withheld are exempt from disclosure pursuant to subsections of the FOIA, 5 U.S.C. § 552, as referenced at the end of this letter. An additional enclosure with this letter explains these exemptions in more detail. Please be advised that for each of the exemptions cited, it is reasonably foreseeable that disclosure of the information withheld would harm the interests protected by these exemptions.

The rules and regulations of the DEA applicable to FOIA/PA requests are contained in the Code of Federal Regulations, Title 28, Part 16, as amended. They are published in the Federal Register available to the public (see <u>https://www.ecfr.gov/current/title-28/chapter-I/part-16)</u>.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c). Responds to requests from the DEA Administrator, Chief of Intelligence, and other internal DEA elements for explanations of intelligence policies associated with budgetary, resource utilization, and publication activities.







Evaluates collection methodology, manges analyses and dissemination of data, and facilitates the exchange of such information with appropriate agencies. Provides advice and assistance to field offices regarding program direction.

Manages production of short and long-term reports forecasting new drug threat activity, new drugs of abuse, availability, and trafficking trends.

Coordinates and conducts liaison with other law enforcement and intelligence agencies to foster and facilitate exchange of information from science-based intelligence programs.

Manages web-based strategic intelligence collection, analysis, and reporting systems.

Manages the STRIDE data analysis project and produces quarterly assessments of drug price and purity trends.
