This letter is in response to your Freedom of Information Act (FOIA) request wherein you seek a "list of the investigations closed by the NLRB Office of Inspector General during calendar years 2020, 2021, and 2022."

This request was received on June 27, 2024, and was routed to the NLRB Office of Inspector General (OIG) on September 16, 2024. This request was assigned FOIA tracking number **2024-NLFO-02673**.

Any appeal should contain a complete statement of the reasons upon which it is based. Please be advised that contacting any Agency official (including the FOIA Public Liaison or me) and/or OGIS does not stop the 90-day appeal clock and is not an alternative or substitute for filing an administrative appeal.
