This includes Profiles (US UN Africa, LATAM, Mideast, South Asia, Europe, etc.) and Features and Obits-News, Obits that need updating, Obit Tapes, Obits- - No Tapes, etc. I am not asking for the obituaries themselves, only the list of individuals for which the obituaries have been pre-written. The fact that someone is well known or prominent is not considered personal or private information."
