This letter responds to your Freedom of Information Act (FOIA) request of September 2, 2024, in which you requested, "A copy of the FOIA Case Log for the Office of Disability Employment Policy for each year between 2010 and present. A copy of the FOIA Appeals Log, if such a record exists, for the Office of Disability Employment Policy for each year between 2010 and present.

Your request was received in our office on September 25, 2024, and assigned FOIA tracking number 2024-F-14727.

We conducted a search we are only able to provide FOIA logs going back to 2013 (attached). As you may know, the Department of Labor transitioned to a new FOIA tracking system in FY2019. At that time, we migrated only the FOIA Case Files sufficient to ensure the legal rights of requesters as contemplated by General Records Schedule 4.3 Information Access and Protection Records. While the underlying FOIA Case Files are governed in accordance with GRS 4.2, Item 020, access and disclosure request files are only required to be maintained for 6 years the overarching records of accounting for and controlling access to records requested under FOIA, PA, and MDR, covered by Item 040, are only required to be maintained for 5 years.
