This is in response to your Freedom of Information Act (FOIA) request to the Office of the Inspector General (OIG). Specifically, you are seeking a copy of the title page and table of contents for all volumes of the Office of Inspector General Manual. The responsive record, consisting of seven pages, has been reviewed. It has been determined that this record is appropriate for release without excision and a copy is enclosed. We consider this response as closing your request with the OIG.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552 (2012 & Supp. V 2017). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal." If possible, please provide a copy of your original request and this response letter with your appeal.
