## RE: Freedom of Information Act Request NGC21-571

This is in response to your Freedom of Information Act (FOIA) request to the National Archives and Records Administration (NARA), dated June 22, 2021, which we received in our office on the same date, via FOIAonline. We assigned your request the above internal tracking number, along with your FOIAonline tracking number NARA-NGC-2021-001065. In your request, you stated:

I request an electronic copy of the inventory of boxes/records maintained for/by NASIC at the Washington National Records Center in Suitland, MD

After conducting a search, we were able to locate two records, totaling in three pages responsive to your request. The PDF labeled PT-342-2013-0828 Box list is being released in full with no redactions. The PDF labeled PT-342-2013-0828 is being released in part with limited redactions pursuant to FOIA exemptions (b)(6). FOIA exemption (b)(6) was asserted to protect the release of information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

This completes the processing of your FOIA request to us.

If you are not satisfied with our action on this request, you have the right to file an administrative appeal within ninety (90) calendar days from the date of this letter via regular U.S. mail or email. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision. If you submit your appeal in writing, please address it to the Deputy Archivist of the United States (ND), National Archives and Records Administration, 8601 Adelphi Road, College Park, Maryland 20740. Both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
