This letter is in response to your 10 February 2025 FOIA submission requesting:

A list of the NGA Office of Inspector General INVESTIGATIONS closed during calendar years 2023 and 2024. The records should include information for each investigation, specifically the case number, the subject of the investigation, the category of the investigation, the open date, and the closing date.

The National Geospatial-Intelligence Agency (NGA) FOIA Privacy Act Requester Service Center initially acknowledged this request. Since the responsive documents are owned by Office of Inspector General (OIG), this letter and the enclosure are provided by NGA OIG.

Regarding the information you requested, NGA OIG conducted a thorough records search of NGA OIG investigations closed from 1 January 2023 through 31 December 2024. NGA OIG closed 74 investigations during that period. The specifics of each investigation are included on the attached spreadsheet. As the NGA OIG initial denial authority for FOIA, I have determined that none of the information in the spreadsheet must be withheld (redacted) based on FOIA exemptions.
