This responds to your request of 25 June 2022 to have the *Oral History of James W. Pryde* reviewed for declassification. The material has been reviewed under the Mandatory Declassification Review (MDR) requirements of Executive Order (E.O.) 13526 and is enclosed. We have determined that some of the information in the material requires protection.

Some portions deleted from the document were found to be currently and properly classified in accordance with E.O. 13526. The information denied meets the criteria for classification as set forth in Section 1.4 subparagraphs (c) and (d) and remains classified TOP SECRET as provided in Section 1.2 of E.O. 13526. The withheld information is exempt from automatic declassification in accordance with Section 3.3(b) (3) and/or (6) of the Executive Order.

Section 3.5 (c) of E.O. 13526, allows for the protection afforded to information under the provisions of law. Therefore, the names of NSA/CSS employees and information that would reveal NSA/CSS functions and activities have been protected in accordance with Section 6, Public Law 86-36 (50 U.S. Code 3605, formerly 50 U.S. Code 402 <u>note).</u>

Please be advised that the responsive document includes another government agency's information. Because we are unable to make a determination as to the releasability of another agency's information, the subject document was referred to the appropriate agency for review. At the time of this letter, the response is outstanding. However, we were able to isolate the other agency's equities, so we have protected them using the other government agency (OGA) redaction code.

TODAY IS 25 AUGUST 1988. OUR INTERVIEWEE MR. JAMES W. PRYDE. MR. PRYDE, SINCE HIS INITIAL ASSIGNMENT WITH THE NATIONAL SECURITY AGENCY IN 1956 HAS BEEN ASSOCIATED WITH THE SOVIET MISSILE TARGET PROBLEM ARES. HIS FIRST DUTIES ENTAILED TELEMETRY ANALYSIS AND HE PROGRESSED IN THE SAME GENERAL FIELD INTO SUBSEQUENT STAFF ASSIGNMENTS, WHICH WERE ALSO RELATED TO THE SOVIET MISSILE ARENA. MR. PRYDE WAS SELECTED IN 1978 BY ADMIRAL INMAN TO BECOME THE DIRECTOR OF DEFSMAC. HIS NEXT AND FINAL POSITION WAS AS NSAREP DEPARTMENT OF DEFENSE AT THE PENTAGON. MR. PRYDE RETIRED FROM THE AGENCY IN DECEMBER OF 1981. THIS INTERVIEW IS TAKING PLACE IN DEFSMAC OPERATIONS BUILDING AT NSA. THE INTERVIEWER, BOB FARLEY, WITH HELEN TUCKER. MR. PRYDE DESIRES THAT THE CLASSIFICATION OF THESE TWO CASSETTES BE TOP SECRET CODEWORD.



AS YOU KNOW THAT NUMBER HAS BEEN GOING LIKE THIS FOR QUITE SOME LONG WHILE. AT THAT TIME THERE WAS EVERYTHING THAT WAS COLLECTED ON THE MISSILE PROBLEM CAME DIRECTLY TO NSA. NOBODY LOOKED AT ANY OF THE DATA, THEY TOLD NSA WHAT THEY GOT AND NSA MADE THE DECISIONS ABOUT WHETHER IT WAS TO BE SENT IN, WHETHER IT WAS TO BE REPORTED, WHETHER THERE WAS...WHAT KINDS OF REPORTS WERE TO BE MADE ON IT AND GRADUALLY IT CAME TO A POINT WHERE THERE



ON RAMADAN OR OTHER HOLY DAYS, AND THAT REALLY GOT TO BE A PROBLEM BECAUSE TWE RUSSIANS KNEW THAT AND A COUPLE OF THEIR PRETTY IMPORTANT EVENTS OCCURED AT.THAT TIME. THE OTHER THING THAT THE RUSSIANS USED TO DO WHICH USED TO MAKE IT FUN, WAS THAT THEY USED TO APPARENTLY LIE CHRISTMAS WEEK, WE USED TO ALL SAY, "GEE, THEY MUST HAVE X NUMBER OF LAUNCHES TO MAKE AND THEY HAVE TO MAKE THEM BY THE END OF THE YEAR," BECAUSE CHRISTMAS WEEK WAS A DILLY ALMOST EVERY YEAR THAT I KNEW ANYTHING ABOUT SMAC.

F: WAS IT TO TAKE ADVANTAGE OF THE AMERICAN'S CELEBRATING THE HOLIDAYS?

P: WE NEVER REALLY DECIDED WHAT THAT REALLY MADE ANY SENSE AT ALL, BECAUSE IN MOST CASES THE EVENTS WERE ROUTINE. THERE WERE JUST LOTS OF THEM DURING THAT PARTICULAR WEEK. WE HAD GIVEN A COUPLE...FIRST OF ALL WE THOUGHT WHAT YOU JUST SAID, THAT WAS THEY FIGURED THAT NOBODY WOULD BE WORKING, THEY'D GO AHEAD AND DO WHATEVER IT WAS THAT THEY WANTED TO DO AND DO SOMETHING SNEAKY. BUT THEY DIDN'T DO ANYTHING SNEAKY, THEY FIRED MORE SS-7s, SS-8s, SAME THING THEY'D BEEN DOING ALL YEAR, UNCHANGED.

F: OKAY, IN A44, THAT'S WHERE SMAC WAS FORMED?

P: SMAC WAS ACTUALLY FORMED IN WHAT WAS A4....

F: A41?

P: NO, A41 WAS THE SMAC DIVISION, AND IT WAS REALLY REAL-TIME TASKING. NSA HAD IN ADDITION TO PROVIDING DATA OR DECIDING WHAT DATA WAS TO BE PROVIDED, NSA ALSO HAD THE JOB OF TELLING THE FIELD SITES WHAT TO COLLECT AND WHEN TO COLLECT IT. THAT'S PRIMARILY WHAT SMAC WAS DOING, WAS FORMED FOR ... TO PROVIDE REAL-TIME GUIDANCE TO THE FIELD. SINCE, THEY HAD THE COMMUNICATIONS, SOMEBODY SAID. "GEE WHY DON'T WE GIVE REAL-TIME REPORTING ON THOSE EVENTS THAT ARE WORTH REPORTING. " THAT WAS THE BEGINNING OF THE SMAC REAL-TIME REPORTING. DEFSMAC GREW OUT OF THAT WHEN THE DEFENSE DEPARTMENT SAID, "GEE WHY DON'T WE NOW, INSTEAD OF MAKING IN JUST SIGINT, WE GOT ALL THESE RADARS AROUND, WE HAVE SOME OPTICAL-SENSORS HERE AND THERE, WHY DON'T WE TRY TO PUT THAT ALL TOGETHER UNDER ONE ROOF AND WE'LL MAKE A DEFSMAC? IN ADDITION TO THAT WE'LL ALSO COP THE NUMBER OF PEOPLE WHO ARE TRYING TO PUT SOMETHING ON THE PRESIDENT OR WHOEVER OTHER MAJOR OFFICIAL IS. THE MORNING AFTER A LAUNCH, THERE WILL BE ONE PLACE FROM WHICH YOU WILL GET INFORMATION OR FROM WHICH THE COMMAND AUTHORITIES WILL GET INFORMATION ON THE SOVIET LAUNCHES." THAT IS DEFSMAC CAME FROM. DEFSMAC WAS A DOD DIRECTED FUNCTION THE TEAM THAT PUT TOGETHER DEFSMAC CONSISTED OF PEOPLE FROM NSA, DIA, OSD

F: WHAT TYPE OF REPORTS DID YOU PUT OUT, INTELLIGENCE AS WELL AS TECHNICAL?

P: ALMOST ALL OF THE REPORTS FROM DEFSMAC WOULD HAVE TO BE LABLED AS INTELLIGENCE. THE TECHNICAL REPORTS CAME OUT PRIMARILY FROM A44 OR FROM THE COMINT PEOPLE IN A43, I THINK THAT'S IT.

F: WHAT AGENCIES IN WASHINGTON DID YOU SERVE? DID YOU SERVE DIA BY GIVING THEM INFORMATION, BUT WERE THERE SOME EXOTIC AGENCIES LIKE SPACE ELEMENTS OR NASA OR SOME OTHER ORGANIZATIONS THAT LIKED TO RECEIVE THESE INTELLIGENCE REPORTS?

P: WELL, THE DEFSMAC INTELLIGENCE REPORTS HAD A STANDARD DISTRIBUTION WHICH INCLUDED EVERYBODY IN THE U.S. GOVERNMENT WHO WAS CERTIFIED TO RECEIVE TOP SECRET CODEWORD, AND I MEAN ALL KINDS OF CODEWORDS, INFORMATION. THE PEOPLE WHO WERE THE PRIMARY CUSTOMERS WERE, DIA, BECAUSE THEY WERE RESPONSIBLE IN DQD FOR PROVIDING TO THE OSD THE EVALUATIONS ON SOVIET MISSILE AND SPACE WEAPONS SYSTEMS. THEY HAD TO BE ABLE TO TELL FTD THE ARMY AND THE NAVY FOLKS WHAT DATA TO ANALYSE, WHAT TO REPORT TO THEM AND WHEN, HOW THEIR SCHEDULES WERE GOING TO BE. THE NASA PEOPLE HAD AN ORGANIZATION THAT HAD SOME CLEARED PEOPLE JUST TO SORT OF KEEP TRACK OF WHAT THE RUSSIANS WERE DOING AND ALSO TO TRY TO DETERMINE WHAT KIND OF IMPACT WHATEVER THE RUSSIANS MIGHT DO IN SPACE WOULD HAVE ON THE NASA SPACE PROGRAM. THE REST OF THE WORLD WAS USED MERELY AS A SOURCE OF ADDITIONAL INTELLIGENCE INFORMATION ON THE THREAT.

F: DID RED STONE ARSONAL CONTRIBUTE ANYTHING AT ALL?

P: NO, NO, NOT TO THE REAL-TIME WORK. RED STONE ARSONAL DID SOME WORK IN ANALYSING TELEMETRY, THEY WERE MEMBERS OF TEBAC. THEY DID MORE, THEY DID THE LONG-TERM ANALYSIS FOR THE ARMY. THE ARMY'S MISSION WAS SHORT-RANGE, INTERMEDIATE-RANGE AND DEFENSIVE WEAPONS SYSTEMS. RED STONE DID A FAIR AMOUNT OF THAT. ANOTHER OUTFIT DOWN IN VIRGINIA ALSO DID SOME OF THEIR WORK. THE NAVY DID ALL NAVAL MISSILES REGARDLESS OF OFFENSE OR DEFENSE AND THE AIR FORCE WAS CHARGED TO DO THE LARGE BALLISTIC MISSILES AND SPACE WEAPONS, BUT THEY DID EVERYTHING ELSE TOO.

F: JUST TO KEEP THEIR FINGER IN?

P: YEP

F: THEY DIDN'T WANT TO BE LEFT OUT HUH?

P: THEY DID NOT WANT TO BE LEFT OUT.

F: MR. PRYDE SHALL WE TALK MORE ABOUT SMAC, OR SHALL WE MOVE INTO THE DEFSMAC ESTABLISHMENT?

P: SMAC WAS...IS...WAS PRETTY MUCH LIMITED TO WHAT I DESCRIBED IT, IT WAS THE PLACE WHERE...THAT HAD THE REAL-TIME COMMUNICATIONS TO THE FIELD AND WHICH WAS THE NSA ARM FOR REAL=TIME BOTH TASKING AND REPORTING OF MISSILE AND SPACE DATA.

F: CAN YOU SIGNAL...SINGLE OUT ONE INDIVIDUAL WHO SAID, "WE HAVE TO HAVE A CENTRAL LOCATION, WE HAVE TO HAVE SOMETHING," THAT LATER BECAME SMAC

P: THAT'S CHARLIE, THAT'S CHARLIE

F: CHARLIE TEVIS?

P: CHARLIE TEVIS

F: CHARLIE TEVIS WAS THE ONE?

P: YES.

F: YEAH, WE HAVE INTERVIEWED HIM AND I THINK THAT HE TOLD US THAT ...

P: HOW IS CHARLIE?

F: OH HE'S GREAT,

T: HE'S STILL SHARP

F: HE LOOKED WELL

P: CHARLIE ACTUALLY LOOKS BETTER, OH I GUESS THAT'S TRUE OF MOST OF US BY

THE WAY, LOOKED BETTER AFTER HE STOPED WORKING THAN HE DID FOR A LONG TIME, BEFORE HE LEFT.

F: HE SEEMED TO HAVE GAINED A LITTLE WEIGHT, AND HE HAD COLOR IN HIS CHEEKS. HE'S DOING WELL

T: MR. PRYDE HAS LOST WEIGHT, I THINK

F: BOY DID HE EVER!

P: THAT'S THE...YOU SEE THAT'S NOT A...IT IS A FAIR AMOUNT OF WEIGHT, BUT I'M STILL A LARGE PERSON, I WEIGH 185 POUNDS.

F: YOU'VE LOST 50 POUNDS I BET..

P: MORE THAN THAT, 70 ACTUALLY. FROM THE ACME OF MY WEIGHT 70 POUNDS, I WEIGHED 250 ONCE. I SHOULDN'T SAY THAT, I HAD A DOCTOR SAY TO ME EARLY, AS LONG AS YOU DON'T WEIGH ANYMORE THAN YOU DID WHEN YOU WERE 20 YEARS OLD, YOU'RE ALRIGHT...WHEN I WAS 20 YEARS OLD I WAS OUR OFFENSIVE FULL-BACK, BLOCKING-BACK AND STRONG SIDE LINE-BACKER, I WEIGHED 250.

F: OH MY, I BET THE DOCTOR DIDN'T KNOW THAT

P: HE DIDN'T, AND I NEVER SAW ANY REASON TO TELL HIM THAT

F: ALRIGHT. DEFSMAC, BY THE TIME YOU BECAME....OH WAIT A MINUTE, WE'VE GOT A COUPLE PLACES TO GO BEFORE WE GET THERE. YOU WENT TO D-3 AS A CRYPTOLOGIC STAFF OFFICER..

P: YEP, THAT CAME OUT OF A SORT OF AN INTERESTING LIFE THAT I LEAD. I SPENT A YEAR IN THE PENTAGON AS A PERSON ASSIGNED TO ASD COMMUNICATIONS SECURITY AND INTELLIGENCE, WORKING FOR BOB FOLKY ((PHON)) I WAS SUPPOSED TO BE AN INDEPENDANT ANALYST ASSIGNED TO THE PENTAGON, NSA PAID MY SALARY, BUT THEY WEREN'T SUPPOSED TO HAVE ANY CONTROL OVER ANYTHING I DID, BECAUSE WE WERE THE INTELLIGENCE PROGRAM EVALUATORS, BUDGETORS, ETC. IT WAS A RELATIVELY SMALL OUTFIT, AND THE FIRST TIME THEY HAD COMBINED ALL OF THAT UNDER ONE ROOF, AND IN ORDER TO MAKE IT WORK, THEY FENCED THE INTELLIGENCE BUDGET FOR THE FIRST TIME. WHICH MENT THAT NOBODY COULD GO AND PIDDLE IN THE INTELLIGENCE DOLLARS, FOLKY OWNED THEM ALL. SORT OF AN INTERESTING SIDE-LINE ON THAT, A FEW YEARS AFTER ALL OF THAT, GENERAL RYAN ((PHON)) DECIDED HE WANTED SOME MORE B-52s SO HE HAD A LINE-ITEM....CAN WE CUT THAT?

F: YOU WANT TO CUT IT?

P: WELL, NO, THAT'S OKAY. THERE WAS A LINE-ITEM IN THE AIR FORCE BUDGET WHICH HAD LOTS OF MONEY IN IT AND RYAN KNEW WHAT THAT LINE-ITEM WAS FOR, AND RYAN SAID, I DON'T CARE WHAT THAT'S FOR I'M GOING TO BUY NEW B-52s WITH THAT MONEY. THAT CAUSE ALL KINDS OF CONSOLATIONS OFF OF THE CIA BUDGET.

F: I CAN BELIEVE IT, WAS HE SUCCESSFUL?

P: OF COURSE NOT.

F: GOOD.

P: IT WASN'T EVEN CLOSE, IN FACT HE WAS TOLD, WHY WOULD YOU WANT TO DO SOMETHING, WHY WOULD YOU EVEN WANT TO PROPOSE SOMETHING THAT UNSMART, IT'S NOT CHARACTERISTIC OF YOU. BUT THAT WAS A YEAR AND FROM THERE I CAME BACK TO THE BUILDING, TO KIND OF TRY AND SPREAD AROUND WHAT I LEARNED ABOUT HOW THE DEFENSE DEPARTMENT WAS PROGRAMMING, BUDGETING, AND ACTUALLY EVALUATING THE

F: SO YOU WENT TO N GROUP.

P: YES

F: AND WHAT KIND OF A POSITION DID YOU HAVE THERE?

P: IN N GROUP I WROTE THE MISSILE SECTION OR THE SPACE SECTION OF THE NATIONAL SIGINT PLAN. WE WERE BUSY TRYING TO WRITE THE FIRST SIGINT PLAN. WE HAD A GREAT BUDGET, BUT EVERYBODY SAY, "OKAY WHAT'S THE BUDGET BASED ON?" AND THERE WAS NO REAL PLAN...THERE WAS A SET OF ORGANIZED THINGS THAT NSA WANTED TO DO, BUT NO STRUCTURED PLAN. WE SPENT A YEAR WORKING TO GET THE FIRST NATIONAL SIGINT PLAN PUT TOGETHER. I DON'T KNOW IF ANYBODY USES IT, EVEN TO THIS DAY. F: I DON'T THINK THE SITUATION HAS IMPROVED AT ALL

P: OKAY.

F: SO, MOST OF YOUR CAREER IS MISSILE RELATED, FROM THE TIME YOU GOT STARTED IN COSA.

P: YES, UH-HUH

F: OKAY, THEN YOU WENT TO W16.

BECAUSE SOMETHING THAT WE ALL KNEW AND LOVED, FLIM-FLAM, WAS GRADUALLY GOING AWAY.

F: I REMEMBER FLIM-FLAM, RIGHT. YOU WENT INTO DEFSMAC AS THE DEPUTY CHIEF?

P: NO...

F: OH, NO WAIT A MINUTE, WE'RE STILL IN, YOU WERE CHIEF OF W16 LATER ON, WHAT CHANGES DID YOU INSTITUTE,? WAS THERE ANY NEED FOR CORRECTING ANY PROBLEM AREAS, OR DID YOU SEE ANY DIFFICULTIES IN KEEPING...

F: OKAY, I'M GOING TO SWITCH TAPES...ALRIGHT SIR, PLEASE CONTINUE

F: HUH, WHAT A COMPLIMENT.

P: IT REALLY IS. AS A TOTAL POPULATION, I DON'T THINK I HAVE EVER SEEN A HIGHER RATIO OF VERY BRIGHT PEOPLE IN ANY ONE LOCATION. KIND OF STRANGE, SOME OF THEM, BUT VERY, VERY BRIGHT.

F: YOU'D HAVE TO BE A LITTLE STRANGE

P: WELL, I DON'T THINK THAT YOU HAVE TO BE, BUT IN THIS CASE IT WAS TRUE.

F: IT DOESN'T HURT. FROM THERE YOU MOVED UP TO W STAFF?

P: YES, IN W I RAN THE RESOURCES PROGRAMS TO TRY TO HELP JIM BOONE GET A HANDLE ON WHAT WE COULD GET FOR THE MONEY WE HAD AND WHAT WE NEEDED TO DO TO GET EITHER MORE MONEY OR FEWER PROBLEMS. GETTING MORE MONEY PARTICULARLY AT THAT TIME TURNED OUT NOT TO BE VERY EASY, IT WAS DURING ONE OF THE, AS YOU KNOW THE DEFENSE SORT OF GOES LIKE THIS...WELL, THAT WAS A PERIOD WHEN IT WAS SORT OF EDGING DOWN TOWARD ONE OF ITS NADIRS. P: I KNEW HE WAS HAPPY. I HAVE NOT SEEN JIM FOR A BETTER PART OF A COUPLE OF YEARS, BUT LAST TIME I SAW HIM, HE HAD JUST MOVED TO A PLACE WHERE HE DIDN'T HAVE TO GO TO THE AIRPORT TO FLY TO WORK EVERY MORNING.

F: OH, YEAH

P: I SAID, "GEE, THINK OF ALL THE PEOPLE WHO WOULD LIKE TO BE ABLE TO SAY THAT THEY HAVE TO FLY TO WORK....THEY ARE FLOWN TO WORK IN THE COMPANY PLANE EVERY MORNING!" HE SAYS, "ITS ALRIGHT TO HAVE TO SAY THAT, BUT GETTING ON AND OFF AIRPLANES IS SOMETHING ELSE." HE HAD GOTTEN KIND OF TIRED OF IT.

F: I CAN BELIEVE THAT

P: WELL, AFTER A WHILE I GOT TO BELIEVE THAT TOO. THERE WAS A TIME IN MY LIFE WHERE THERE WAS NOTHING BETTER THAN AN AIRPLANE. BUT YOU JUST CAN'T DO THAT TOO MANY TIMES, I FIND.

F: WHEN YOU WERE IN W STAFF, MR. PRYDE, DID YOU HAVE ANY DESIRE TO MOVE IN AND TAKE OVER THE DIRECTORSHIP OF DEFSMAC?

P: I ALWAYS WANTED TO BE THE DIRECTOR OF DEFSMAC. DEFSMAC WAS ONE OF THE PLACES THAT I THOUGHT WAS REALLY A FUN PLACE TO WORK. I HAD BEEN ASSOCIATED WITH DEFSMAC IN ALL OF THE OTHER JOBS I HAD IN W,

AND ALL

OF THOSE LOCATIONS GAVE ME A GOOD VIEW FOR, AND A DESIRE TO BE ASSOCIATED WITH DEFSMAC IN A REAL-TIME SENSE. EVEN BACK IN THE DAYS WHEN I WAS ON THE A STAFF, THE SMAC, WHICH BECAME DEFSMAC, THOSE WERE THE GUYS THAT I'D HAVE TO GO TALK TO AT NIGHT SO THAT I'D BE READY TO GO AND DISCUSS THE LAUNCH AT 8 O'CLOCK THE NEXT MORNING. SO, IT WAS NOT AS IF SOMEBODY CAME AND SAID, "HEY I HAVE THIS STRANGE JOB FOR YOU." IT WAS A JOB THAT I BOTH KNEW AND YOU THE JOBS YOU'D LIKE TO HAVE, DEFSMAC WOULD HAVE BEEN THE TOP ONE.

F: DID YOU COME IN AS A DEPUTY?

P: NOPE

T: STILL THE SAME, STILL THE CURRENT ONE

F: DID YOU WORK WITH ...

P: MAX MITCHELL?

F: MAX MITCHELL, RIGHT.

P: YES. I KNEW MAX WHEN...BOTH IN DIA BEFORE HE CAME HERE AND MAX WAS HERE



IN NSA, AS A MILITARY OFFICER BEFORE BECAME THE DEPUTY OF DEFSMAC.

F: JOE ORSHMAN ((PHON))

- P: JOE WAS MY DEPUTY.
- T: THAT'S WHAT I WANTED TO KNOW
- P: THE CHAPLAIN.

T: YES.

F: HE'S ALMOST A PRIEST NOW, HE'S STILL SO RELIGIOUS

P: HE WAS...I HAVE TO TELL YOU THAT JOE WAS ALMOST A PRIEST WHEN HE LEFT HERE TO GO TO FLORIDA. JOE, I WENT TO JOE'S, I GUESS YOU CALL IT ORDINATION, THE BISHOP OF BALTIMORE ORDAINED HIM. EXCEPT FOR HAVING A WIFE, JOE IS AS MUCH A CATHOLIC PRIEST AS ANYBODY I'VE EVER KNOWN.

F: JOE AND I ARE CLASSMATES FROM KRATIN ((PHON)) UNIVERSITY, JESUIT COLLEGE OUT IN OMAHA, NEBRASKA. SO, I'VE KNOWN HIM A LONG TIME.

P: HAVE YOU SEEN OR HEARD ANYTHING FROM HIM?

F: ABOUT THREE YEARS AGO, WE WERE DOWN IN ORLANDO FOR A PHOENIX SOCIETY GATHERING, HE'S DOING WELL, HE'S HAPPY.

P: IF YOU HAPPEN TO RUN ACROSS HIM, TELL HIM I ASKED ABOUT HIM

F: I SURE WILL, I SURE WILL. I WAS JUST TRYING TO PLACE YOU IN TIME AND WHO YOUR DEPUTY WAS, BUT THAT'S FINE.

P: NO, I WAS TRYING TO REMEMBER WHO MAX'S DEPUTY WAS


T: THE DEPUTY....

P: YEP, BECAUSE MAX CAME TO WORK AT NSA AS A CIVILIAN TO BECOME THE CHIEF OF DEFSMAC. THEN GORDON STARK AND THEN JOE ORKMAN ((PHON)) AND I.

F: OKAY, SO BY THAT TIME, DEFSMAC HAD BEEN IN EXISTANCE FOR ABOUT 15 YEARS. WHEN YOU WALKED IN, DID YOU FEEL THAT IT WAS RUNNING VERY SMOOTHLY AND THERE WERE PROBABLY NOT MANY CHANGES YOU WOULD IMMEDIATELY MAKE, OR DID YOU HAVE A LOT OF CHANGES, SUGGESTIONS IN THE BACK OF YOUR MIND?

P: NO, ONE OF THE THINGS THAT I ALMOST NEVER DO IS GO TO A NEW JOB WITH AN IDEA OF CHANGING WHAT IS A SUCCESSFUL ORGANIZATION. I THINK THAT IS IN BAD TASTE TO BEGIN WITH, AND I THINK A LOT OF PEOPLE MAKE AN ERROR JUST BELIEVING THAT YOU HAVE TO CHANGE SOMETHING BECAUSE "I'M HERE NOW." OVER ALL OF THE YEARS THAT I HAD KNOWN ABOUT DEFSMAC, THERE WERE VERY FEW THINGS THAT.I THOUGH DEFSMAC DID IMPROPERLY. OVER TIME, THERE WERE SOME CHANGES TO BE MADE, NOT BECAUSE DEFSMAC WAS DOING THEM IMPROPERLY, BUT BECAUSE THERE WERE BETTER WAYS TO DO SOME OF THEM. ONE OF THE ONES THAT WE INSTITUTED WAS TO INVOLVE THE SOFTWARE PEOPLE WITH THE REST OF THE DEFSMAC ORGANIZATION IN DEVELOPING SOFTWARE THAT WAS USEFUL TO EVERYBODY, NOT JUST TO THE SOFTWARE PEOPLE. AND TO HAVE US UNDERSTAND WHAT THE SOFTWARE PEOPLE WERE DOING. THEY WOULD GO OFF IN THE CORNER AND COME OUT, "HERE'S A PIECE OF SOFTWARE FOR YOU" WE SAID, "YOU CAN'T DO THAT ANYMORE. WE ARE ALL GOING TO START OFF WITH OUR REQUIREMENT, YOU ARE GOING TO UNDERSTAND WHAT THE DEFSMAC REQUIREMENT IS, WE'RE GONNA UNDERSTAND WHAT YOU ARE GOING TO DO TO SATISFY THAT, AND WE ARE GOING TO HAVE PERIODIC REVIEWS, AND WE HAD THOSE, AND I TURNED OUT TO HAVE WORKED OUT VERY WELL. THAT'S ONE OF THE THINGS THAT SORT OF HELPED ME WHEN I DECIDED TO GO OFF AND DO SOMETHING DIFFERENT AFTER I RETIRED.

F: UH-HUH. SO, YOU DIDN'T INSTITUTE MANY INOVATIONS IMMEDIATELY? OGA PL 86-36/50 USC 3605 P: NO INOVATIONS IMMEDIATELY. THE THINGS THAT WERE CHANGED WERE PRIMARILY. FROM OUTSIDE PRESSURES, ON OF THE..

F: OKAY. SO YOU NEVER HAD TO COUNTERMAND ANY DECISIONS OR ANY ORDERS

P: NO, IF I DIDN'T LIKE SOMETHING THAT JOE DID, JOE AND I WOULD GO INTO MY OFFICE AND WE WOULD TALK ABOUT THAT, BUT JOE WOULD BE OF NO VALUE AS A DEPUTY TO ME IF I HAD TO GO, IF I WENT AND TOLE SOMEBODY, "GEE, I DON'T LIKE WHAT JOE DID, I'M GOING TO CHANGE THE ORDER."

F: GOOD...

P: YOU KNOW, IF JOE DID SOMETHING THAT WAS ABSOLUTELY DAMAGEING TO THE ORGANIZATION, I'M SURE THAT I WOULD HAVE DONE THAT, BUT ALSO, I HAD ENOUGH CONFIDENCE IN JOE THAT I DON'T BELIEVE THAT HE WOULD HAVE DONE THAT. HE WOULD HAVE PASSED THE OPPORTUNITY TO MAKE THAT DECISION.
