Pursuant to the Order of U.S. District Judge Harold H. Greene in the civil matter American Friends Service Committee, et al. v. William H. Webster, et al, Civil Action Number 79-1655, U.S. District Court, Washington, D. C., representatives of your staff visited the Federal Bureau of Investigation on June 1, 1982, to conduct an appraisal of memorabilia of J. Edgar Hoover, former Director of the Federal Bureau of Investigation, to determine its historical or research value.

Members of your staff conducting the appraisal requested an inventory of the material, which is enclosed. There is a total of 91 boxes which house the memorabilia. Attached are copies of two interviews, form FD-302s, of former Inspector [redacted] now retired, and accompanying inventories which identify 88 of the boxes and describes the contents of each. There are three additional boxes numbered 70, 71 and 72, which contain the following material:

Box number 70 - Crate 2 ft. x 6 ft. containing a bow and arrow exhibit from the National Bureau of Investigation, Manila, Phillipines

Box number 72 - Crate 3 1/2 ft. x 5 ft. containing an aluminum portrait of Mr. Hoover.

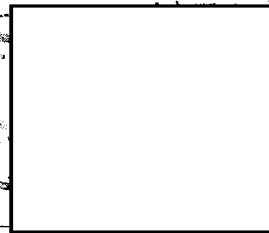

Pursuant to the August 26, 1981, Order of U.S. District Judge Harold H. Greene in the civil matter American Friends Service Committee, et al. v. William H. Webster, et al, Civil Action Number 79-1655, U.S. District Court, Washington, D. C., I request that you assign an archivist to the Raleigh, North Carolina, Resident Agency (RA) of the FBI Charlotte Field Office to examine documentary evidence.

By way of background, in the case captioned "M. Steinthal Division of the Steinthal Corporation, Doing Business As Roxboro Industries; et al.; Fraud Against the Government - Department of Defense (Contractor Fraud)," the books and records of captioned bankrupt corporations were voluntarily contributed to the FBI Charlotte Field Office. It is noted that the volume of records approximated the capacity of six 40 foot moving vans. The bankruptcy trustee has some companies interested in purchasing a portion of the records and desires to be able to release the records, as well as sell the approximate 300 file cabinets, which currently contain some of the records.

By letter dated June 7, 1982, the Department of Justice declined criminal prosecution while referring it to the Civil Division for possible prosecutive potential. In the event of civil prosecution in this matter, the records which relate to the civil action will be contained in ten or less boxes. The FBI Charlotte Field Office desires to release the records to the trustee and to dispose of those he may abandon so that the space currently being rented by the FBI for storage of these records may be vacated.

Due to the large volume of documentary evidence involved, it would be impractical for the FBI Charlotte Office to forward these documents to FBIHQ for review by a member of your

The material lacks sufficient research or other value to warrant permanent retention in the National Archives and may be returned to its owner.

I understand, however, that the New Rochelle staff wish to retain those documents related to the Chase Manhattan Bank and Diners' Club accounts for probable presentation to a Federal grand jury. If that material is so presented, it should be re-examined for disposition in light of the grand jury's actions.

An appeal to an administrative board of the National Transportation Safety Board resulted in [REDACTED] acquittal. Subsequently, [REDACTED] began receiving letters, six of which he made available, which [REDACTED] believed to be threatening. The text of the message in the letters strongly suggested the author was possibly an FAA employee involved in filing the aforementioned charges against [REDACTED]. An AUSA, NDGA declined prosecution stating the letters, although insulting, were not extortionate. The FAA pilots have since filed a civil action against the FAA.

The Boston Office is in possession of a large volume of evidentiary material seized in Boston Case entitled [REDACTED] DBA Northeastern Video Associates, Middlesex Ave., Lowell, Massachusetts, Copyright Matter," BS file #28C-580. The case has been adjudicated and the Boston Office was issued an order by the U. S. Magistrate in Boston to return the bulk of the evidence to Reed.

Due to the large volume of evidence involved, it would be impractical for the Boston Office to forward the material to FBIHQ for review by a NARS Archivist. Contact with NARS, Washington, D. C., disclosed that NARS is operating under severe budget constraints which would preclude an Archivist being dispatched to the Boston Office to examine the evidence in question. During conversation with Dr. James E. O'Neill, Assistant Archivist for Presidential Libraries, FBI Appraisal Project Director, NARS, Washington, D. 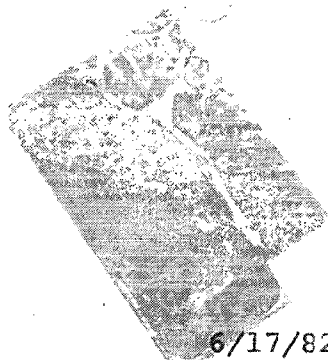

With the exception of the Mexico City Office, no Legat office utilizes a preprinted file front to accommodate investigative and administrative records. Legat offices utilize plain brown colored file fronts for this purpose.

For security reasons and the prohibition of file destruction, it has been necessary for several Legat offices to forward a portion of their records holdings to FBIHQ for dead storage. Since the file covers containing these records stored at FBIHQ bear no identification of the Legat office to which they pertain, it has been necessary to mark these file covers when removed from dead storage and routed within FBIHQ. In addition, the proposed retention plan and disposition schedules developed by the FBI and the National Archives and Records Service (NARS), which are presently being considered by the U.S. District Court, Washington, D. C., stipulate that certain Legat investigative records must be retained permanently for eventual transfer to NARS. These files will be forwarded to FBIHQ for storage, prior to being transferred to NARS after a 50-year period from the time the case was closed. Based on the foregoing, a unique colored file front is being designed at FBIHQ for use by all Legat offices. This file cover will not contain the U.S. Department of Justice or FBI logo, but will simply contain the notation "Legat File" with a space provided to enter the particular Legat office's telegraphic abbreviation.

The foregoing is for your information. Forward any suggestions or observations you may have concerning the development of the file cover for use by Legat offices to FBIHQ, attention Records Systems Section, Records Management Division.

NOTE: Legats are being advised of the design and development of a uniquely colored file front for use by Legat offices. Legats are invited to offer any comment, observation or suggestion concerning the design and development of Legat file fronts by FBIHQ.

If that material is so presented, it should be re-examined for disposition in light of the grand jury's actions.

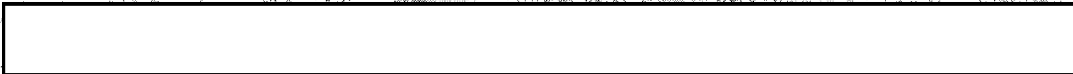

In response to the Bureau's request of May 19, 1982, to make an archivist available to review material relating to a case originating in Boston, Dr. Ethel W. Hedlin of our staff examined the materials at the Boston Field Office on June 17, 1982.

The documentary material reviewed by Dr. Hedlin relates to Boston Case File No. 28c-580 and consists of approximately 502 video cassettes onto which were illegally taped 1,500 motion picture films. This material was seized legally by Bureau agents through a search warrant. The subject has been convicted and sentenced. The court's final judgment contains an agreement between the Bureau and the subject that after the FBI erases the motion picture films, all but 100 of the tapes will be returned to the subject.

This material lacks sufficient evidential or informational value to warrant permanent retention and may be disposed of in accordance with the agreement.

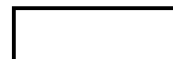

The FBI has no record of having received the referenced May, 1980 bill. The referenced account was closed after it was determined, through the National Archives and Records Services Central Office in Washington, D. C., that no further bills were forthcoming. Despite this I have directed that payment be withheld for that part of your bill for which services were rendered.

On February 5, 1977 the FBI contracted with NARS to provide technical assistance in the study of word Processing (WP) Systems at FBI Headquarters (FBIHQ), and the Richmond, Virginia, Field Office. FBI Purchase Order (PO) #7834 in the amount of \$145,000 (\$130,000 for FBIHQ and \$15,000 for Richmond) was issued to GSA Finance Division, Washington, D. C. On April 4, 1980, FBI PO #4213, in the amount of \$15,000, was issued to cover additional work required at FBIHQ. The FBIHQ study was completed in April, 1980, and the Richmond study was cancelled due to unexpected delays in the FBIHQ work. (The study team did visit Richmond for two days, including travel, for a proficiency survey).

ReButel indicated that a 7/28/81 Order issued by Judge Greene permitted the return of documentary evidence at the request of the owner/contributor, provided the FBI made a legible machine copy of each document returned and retained same. Considerable personnel and material costs have been incurred by the FBI in copying Grand Jury documentary evidence retained by the FBI which the owner/contributor requested be returned. In light of Judge Greene's 6/17/82 Order, you should refrain from copying any documentary evidence secured through the service of a Grand Jury subpoena, which the owner/contributor requests be returned. You should refer the owner/contributor to the Office of the U.S. Attorney in your territory and coordinate this matter with the U.S. Attorneys Office. Advise FBIHQ via teletype of each instance wherein a court order is issued for the return of documentary evidence of a Grand Jury nature. The teletype should be submitted under the individual case caption and marked for the attention of SA Robert W. Scherrer, Section Chief, Records Systems Section, Records Management Division.

Instructions for the return of non-Grand Jury documentary evidence at the owner's/contributor's request, as set forth in reButel, remain unchanged.

FIRST, PURSUANT TO ORDERS DATED JANUARY 10, 1980 AND JUNE 9, 1981, THE FBI IS ENJOINED FROM DESTROYING, OR OTHERWISE DISPOSING OF, ANY FBI FILES, INCLUDING GRAND JURY DOCUMENTARY MATERIAL, UNTIL A RECORDS RETENTION PLAN AND DISPOSITION SCHEDULES ARE SUBMITTED TO AND APPROVED BY THE DISTRICT COURT, EXCEPT AS MODIFIED BY THE JULY 28, 1981 AND THE JUNE 17, 1982 ORDERS IN AMERICAN FRIENDS SERVICE COMMITTEE. (ORDERS FORWARDED BY MAIL). SECOND, PURSUANT TO THE JUNE 17, 1982 ORDER, GRAND JURY DOCUMENTARY MATERIAL IN THE POSSESSION OF THE FBI MAY ONLY BE RETURNED BY THE FBI DURING THE PENDENCY OF THIS CASE IF A FEDERAL COURT ORDERS THAT SUCH DOCUMENTS BE RETURNED AND THE GOVERNMENT HAS INFORMED THE COURT OF JUDGE GREENE'S DETERMINATION OF THE

APPLICABILITY OF THE ARCHIVAL STATUTES. THE FOLLOWING GUIDELINES SHOULD BE FOLLOWED WHEN THE QUESTION OF THE RETURN OF GRAND JURY DOCUMENTS ARISES.

1. YOU CAN ADVISE OWNERS OF GRAND JURY DOCUMENTS FOR WHICH IT HAS BEEN DETERMINED THAT THERE IS NO LONGER A LAWFUL CIVIL OR CRIMINAL INVESTIGATIVE OR PROSECUTIVE NEED THAT THE FBI IS PRECLUDED FROM RETURNING SUCH DOCUMENTS WITHOUT RETAINING COPIES PURSUANT TO ORDERS DATED JANUARY 10, 1980; JUNE 9, 1981, AND JULY 28, 1981, IN AMERICAN FRIENDS SERVICE COMMITTEE V. WEBSTER, EXCEPT AS MODIFIED BY THE ORDER DATED JUNE 17, 1982.

2. IF THE OWNERS OF SUCH DOCUMENTS REQUEST THEIR RETURN, YOU MAY ADVISE THEM THAT, PURSUANT TO THE ORDER DATED JUNE 17, 1982, THEY MAY SEEK AN ORDER FROM THE COURT IN WHICH THE GRAND JURY WAS EMPANELLED TO ALLOW THEIR RETURN.

3. IN RESPONSE TO SUCH MOTIONS BY OWNERS OF GRAND JURY DOCUMENTS, YOU SHOULD INFORM THE COURT: (A) THAT THE FBI IS ENJOINED FROM DISPOSING OF SUCH DOCUMENTS WITHOUT COPYING PURSUANT TO THE ORDERS DATED JANUARY 10, 1980; JUNE 9, 1981 AND JULY 28, 1981, EXCEPT AS MODIFIED BY THE JUNE 17, 1982 ORDER (AND PROVIDE THE COURT WITH COPIES THEREOF); (B) THAT THE ORDER DATED JUNE 17, 1982 IN AMERICAN FRIENDS SERVICE COMMITTEE PERMITS THE FBI TO RELEASE SUCH DOCUMENTS WITHOUT RETAINING COPIES UPON COURT ORDER IF THE GOVERNMENT HAS INFORMED THE COURT OF JUDGE GREENE'S DETERMINATION OF THE APPLICABILITY OF THE ARCHIVAL STATUTES; AND (C) THAT THE MEMORANDUM OPINION OF THE DISTRICT COURT IN AMERICAN FRIENDS SERVICE COMMITTEE V. WEBSTER, 485 F. SUPP. 222 (D.D.C. 1980), APPEAL DOCKETED, NO. 81-1980 (D.C. CIR. SEPTEMBER 1, 1981), CONTAINS JUDGE GREENE'S ARTICULATION OF THE APPLICABILITY OF THE ARCHIVAL STATUTES.

4. IN ADDITION, ALTHOUGH YOU NEED NOT OPPOSE SUCH MOTIONS, YOU SHOULD INDICATE TO THE COURT THAT WHILE THE GOVERNMENT IS APPEALING THE JANUARY 10, 1980 ORDER, AS AMENDED, THE FBI IS STILL ENJOINED FROM RETURNING SUCH DOCUMENTS WITHOUT RETAINING COPIES DURING THE PENDENCY OF THIS ACTION UNLESS AN ORDER IS ISSUED PURSUANT TO THE COURT'S ORDER DATED JUNE 17, 1982. Pursuant to the August 26, 1981, Order of U.S. District Judge Harold H. Greene in the civil matter American Friends Service Committee, et al. v. William H. Webster, et al, Civil Action Number 79-1655, U.S. District Court, Washington, D. C., I request that you assign an archivist to the FBI Baltimore Office to examine documentary evidence turned over to the FBI by the Baltimore City Police Department.

By way of background, defendants in the case captioned "Clean Streets; Racketeer Influenced Corrupt Organization" claimed through pretrial motions that the Government's investigation was tainted by illegal searches conducted by the Baltimore City Police Department in 1976 and 1978. As a result of the 1976 search, the Baltimore City Police Department prepared a report, which has become known as the "Norton Report," which details a review of documents seized. Copies of the report are maintained by the FBI Baltimore Office and FBI Washington Field Office. As a result of the 1978 search by the Baltimore City Police Department, information and documents were turned over to the FBI Baltimore Office. This information, along with the "Norton Report," were filed in the above-mentioned case file by the FBI Baltimore Office. The Maryland State Courts subsequently declared both the 1976 and 1978 searches by the Baltimore City Police Department were illegal. On February 4, 1980, the FBI Baltimore Office executed four search warrants in the above case. As a result of these searches, thousands of documents were seized and are currently being maintained by U.S. Attorneys Office, Baltimore, Maryland. As a part of a plea agreement, the Government has agreed to return to the Baltimore City Police Department all copies of the "Norton Report" and to return all copies in the FBI's possession of documents seized by the Baltimore City Police Department in 1978, along with all documents seized by the FBI in 1980. The FBI Baltimore Office file number in this case is 145A-953.

Pursuant to the August 26, 1981, Order of U.S. District Judge Harold H. Greene in the civil matter American Friends Service Committee, et al. v. William H. Webster, et al, Civil Action Number 79-1655, U.S. District Court, Washington, D. C., I request that you assign an archivist to the FBI Washington Field Office to examine documentary evidence provided the FBI by the Immigration and Naturalization Service (INS).

By way of background, the INS provided the FBI Washington Field Office with transaction history computer print-outs for the case captioned [redacted] Theft of Receipts from Immigration and Naturalization Service (INS), Regional Office, Washington, D. C.; Theft of Government Property." These transaction histories are used to keep track of computer usages and act as a safeguard against employee misuse of the computer. The fact that these records are presently retained in the bulky evidence room at the FBI Washington Field Office is an inconvenient arrangement for INS personnel when the need arises to consult the transaction histories. INS personnel have requested the return of these documents in order to simplify research of these records for problems or discrepancies which may have occurred. The FBI has no additional need for these records inasmuch as subject pleaded guilty and was sentenced.

You were previously advised that NARS had been requested to consider the court-ordered disposition of a number of video cassettes containing pirated motion picture films, which are being retained as evidence by your office. NARS advised consideration was being afforded to order Kenneth F. Rossman of the NARS Los Angeles Federal Archives and Records Center to Honolulu in order to review the video cassettes in question. For your information, NARS had previously considered having a Special Agent from your office submit a sworn affidavit certifying that the evidence to be disposed of by your office was in fact video cassettes containing pirated motion picture films; however, the U.S. Department of Justice Civil Division indicated that this procedure would probably not be acceptable to U.S. District Judge Harold H. Greene, who is the presiding Judge in the civil matter American Friends Service Committee, et al. v. William H. Webster, et al., U.S. District Court, Washington, D. C., Civil Action Number 79-1655. NARS advised that video cassettes containing pirated motion picture films obviously have no archival or historical value, since the original motion pictures are maintained by the motion picture industry. The only issue to be resolved for the disposition of these video cassettes is an acceptable certification to the Court that this evidence is in fact pirated video cassettes.
